#### **Precious Little Time Remains**

There was a flare of the dramatic at times as the pressure of the looming sine die deadline continues to build. At one point, House Democrats were accused of intentionally not showing up to prevent action on a piece of legislation. At another point, Senator Larry Martin (R-Pickens) expressed his frustration on the Senate floor stating, "We just blew through a legislative day with nothing being done, and we have precious few days left." ### **Another Bathroom Bill Looms**

On Tuesday, Senator Larry Grooms (R-Berkeley) introduced a local bill to overturn the recent Berkeley school district's policy to allow students to use restrooms with which they identify. Opponents tried delaying the bill on Wednesday by raising a point of order on whether the bill was local legislation since it could have statewide ramifications. The efforts failed on Wednesday and the bill was given second reading. On Thursday, another point of order was raised for the same reason after new information was presented to lawmakers from the State Superintendent of Education Molly Spearman who asked for a delay on a vote until the school board meets next week. Senator Brad Hutto (D-Orangeburg) explained his new point of order motion was based on a letter from the

Total votes out of 156 in both the House and Senate that were against overriding the Governor's veto of the farm relief bill. The override easily achieved the needed 2/3 vote to override in both bodies.

# \$870 Million

Estimated amount of statewide education funding that could be in jeopardy if the Berkeley Department of Education that explained the bill could potentially not only put the \$26 million of Berkeley Country federal funding at risk, but the entire statewide \$870 million. He believes the Superintendent of Education could not sign off saying the state has no Title IX violations if there is this discrimination occurring in the state. The point of order has not been ruled on by Lt. Governor Henry McMaster and is still pending as the Senate voted 20-15 to carry the bill over and adjourn for the day. The point of order will be ruled on when the Senate returns on Tuesday.

#### Legislature Overrides Farm Relief Veto

The House and Senate easily gave the needed votes to overturn Governor Haley's veto of the \$40 million farm aid bill. The bill would allow farmers who lost over 40% of their crop to receive a grant of no more than \$100,000 to cover 20% of the loss on a first-come, first-serve basis. While the Governor vetoed the bill saying it would be an "unprecedented bailout", Speaker Lucas and other lawmakers pointed out that farmers don't have access to federal disaster-relief funding programs that small businesses and homeowners are eligible for. After the votes, the Governor said there were no winners in last year's 1,000 year flood, and the state will continue to do our best to help all industries through the recovery process.

#### **Refugee Bill Fails to Advance**

The Senate-passed bill that would require refugees in South Carolina to register in the state had difficulty advancing this week after the hearing was unable to have a quorum to take action. Committee Chairman Greg Delleney (R-Chester) blamed Democrats since Representative James Smith (D-Richland) was the only Democrat in attendance. There were Republicans absent as well. The Chairman rescheduled the meeting for Thursday, and the committee immediately voted to adjourn debate on the bill without debate or discussion.

#### **The Week Ahead**

Both bodies will work diligently to get through their calendars which features 102 bills in the Senate and 42 bills in the House currently. The House was able to pass the independent investigations ethics bill this week and will likely consider the income disclosure legislation next week. The House amended the budget and sent it back to the Senate and there will likely be a conference committee that will meet starting next week.
