### About the Seminar

This seminar will present the role of the Department of Interior's Appraisal and Valuation Services Office (AVSO) as it pertains to valuation assignments such as land acquisition, real estate exchanges, and market rent assignments. Changes to the 6<sup>th</sup> Edition of the Uniform Appraisal Standards for Federal Land Acquisitions (UASFLA), also referred to as the "Yellow Book" will be presented. The final session will cover deficiencies encountered while reviewing assignments for federal agencies.

#### **Learning Objectives**

Attendees will learn more about: 1) engagement of contract appraisers by the Appraisal and Valuation Services Office (AVSO) and other federal agencies, 2) highlights of the sixth edition of the Uniform Appraisal Standards for Federal Land Acquisition (UASFLA) and 3) common errors in UASFLA.

#### Instructor / Developer

**Michael J. Brady MAI, SRA, AI-GRS** is currently employed as a review appraiser with the Department of Interior, Appraisal and Valuation Services Office. He has been active in the real estate business since 1985 and has appraised all types of residential, commercial, and special use properties. Mr. Brady served as a Special Magistrate for the Value Adjustment Boards of Broward, Martin and Palm Beach County, Florida. Brady is a member of the International Right of Way Association and served as president for the IRWA chapter 76 in 2007 and 2008. He is a designated member of the Appraisal Institute and was recognized as a volunteer of distinction for Region X in September 2011. He is a Certified Instructor for the Appraisal Institute and holds a State of Florida Certified General Real Estate Appraiser and State of Georgia and Florida Real Estate Broker's license.

**Continuing Education** – This seminar is approved by the Appraisal Institute and the GA Real Estate Appraisers Board for 3 hours of continuing education credit.
