





Government Relations

State News

The Appraisers Bill (H. 3278) is in the purview of the House Labor, Commerce, and Industry Committee. After the bill was pre-filed in the fall, additional discussions continued between stakeholders and a number of new changes were proposed. All stakeholders including the Realtors Association, the Appraisers Board, Appraisal Institute, and the Real Estate Valuations Advocacy Association (REVAA) reached consensus and language was thereafter provided to the Committee along with a joint letter of support.

The organizations have jointly relayed that the proposed amendments are important to helping South Carolina remain compliant with federal requirements and provide needed clarity to appraiser and appraisal management company "AMC" licensees.

The SC Association of REALTORS® specifically recognized the importance appraisers play in the real estate process and worked alongside stakeholders to bring these much needed updates to the appraisal profession. We assured legislators that the current version address the issues raised in the drafting process.

The bill remains a priority for the Appraisal Institute and will remain in play, even as the regular session adjourns May 11. We will continue to advocate for the compromise language and keep our state's Appraisers Board compliant so that home purchases and financing are not interrupted.
