# **PRESIDENT'S LETTER**

Anthony "Tony" Martin, MAI 2025 SCAI President



Dear Members,

My name is Tony Martin, and I'm honored to introduce myself as your 2025 Chapter President. I operate the A.R. Martin Company in Lexington, South Carolina, where my appraisal practice focuses primarily on eminent domain valuations. My wife and I are blessed with four children and two grandchildren, and I'm truly grateful for the opportunity to give back to an organization that has given so much to me and my family over the years. It's already been quite a year—both for our national organization and our local chapter. Before I touch on some of the recent developments at the national level, I'd like to take a moment to highlight the important work and accomplishments happening here in South Carolina.

In January, we hosted a virtual seminar titled "Protecting Yourself" with attorney Craig Capilla. Craig did an outstanding job, and I highly recommend this class to anyone who hasn't taken it yet. It provided invaluable insights into professional risk management something we can never know too much about.

In April, we held our first in-person Economic Summit since before COVID, and it was a resounding success. We had over 30 attendees and five outstanding speakers. A big thank you goes to Jody Odom, MAI, for hosting this event. Our speakers included:

- Cameron Yost (Lee & Associates) offered key insights on the challenges in the office market
- Mandy Coleman (National Restaurant Properties) shared restaurant property trends, particularly in the Charleston market. It was funny to hear her say that quite often the buyer of a restaurant property is a bored, very wealthy person who has no idea how to operate a restaurant.



- Hagood Morrison (Bridge Commercial) delivered compelling information on the industrial market, which is probably the hottest property type right now. It was quite crazy to learn that tracts of land with potential for data center development are probably unable to be valued because the prices paid have no basis in the local market......Google, Meta and the likes simply pay whatever it takes to obtain such properties.
- Rox Pollard (Colliers International) spoke about the continuing strength of the retail market. Now that the market has absorbed the empty big box stores and malls have transitioned to numerous retail service tenants, the retail market appears to be as strong as ever.
- Rob Salvino (Coastal Carolina University) provided an interesting and wide-ranging economic overview of the real estate market

Please thank these individuals if you have the opportunity—and also extend your thanks to Ben Hayes, MAI, who has worked tirelessly for the last few years to elevate our chapter's education programs, including organizing this Summit. I don't know how Ben found the time to develop our education and still produce appraisals!

Looking ahead, we have two more education offerings planned for 2025. One will focus on the new URAR residential form. If you're involved in residential work—or know others who are—this class will be vital. It will be offered in person to foster the kind of interaction and camaraderie we often miss in virtual settings. Another class, likely virtual, will be announced soon, so please stay tuned.

In April, I attended the national Appraisal Institute meeting in Clearwater, Florida. This was one of two annual gatherings where chapter and regional leaders meet face-to-face with national leadership. The meeting opened with a live broadcast of <u>Al's "Face Value" podcast</u>, which I encourage you to check out if you haven't already.

Our national leadership expressed optimism, but it's clear we are facing significant challenges as an organization. As many of you know, the CEO hired in late 2023, Cindy Chance, was terminated less than a year into her tenure. Her dismissal, right before last year's Kansas City meeting, which I also attended, raised many difficult questions. Many appraisers who asked questions of leadership were very passionate about their concerns and the emotional temperature in the room got a bit elevated.National leadership has largely remained silent on details, citing legal constraints. Since then, Ms. Chance has filed a lawsuit against the Appraisal Institute and our current Vice President, alleging wrongful termination and sexual harassment. There is also news that a whistleblower lawsuit has been filed by a different former employee, with these claims being detailed in a recent New York Times article. While AI leadership has strongly denied the fraud allegations mentioned in the article, the situation remains fluid.

Despite the turbulence, and on a brighter note, I can report that the leadership of the local chapters are people that care passionately about AI and want the best for our organization and our members. I know this because a chapter president in Pennsylvania, Justin Gohn, MAI, started an e-mail group in January for current presidents. We have had two zoom meetings to share success stories, struggles and ideas to improve individual chapters and the national organization. These meetings are grassroots and not planned through national so many things said and emailed can be rather unfiltered but that can be a good thing because not everything is sunshine and puppies right now.As the news of the lawsuit has unfolded my inbox has been flooded with emails from this president's group and many chapters have already had their board compose a letter to National leadership calling for accountability and clarification on the path forward. With the LDAC (Leadership Development and Advisory Council)



conference taking place this week in Washington, D.C., most Chapters are waiting to see if any new information comes out before taking further steps.

One thing these meetings with other chapter presidents has made me realize is how fortunate we are to have Sarah Walsh as our executive director. Many chapters are struggling to find experienced, capable executive directors. While there are companies that will provide services to help run a small non-profit, like we are, those companies and the executive directors they put in place have no idea about the minutia that goes along with everything Al.Sarah has vast experience not only with Al national but also with being an executive director for local chapters.We are lucky to have her, and she certainly keeps me in line and makes sure my responsibilities as president are met.Please make sure to seek her out and thank her the next time you see her.

Lastly, at our April board meeting, I shared news that the Savannah Chapter president discussed at the national meeting in Clearwater that the Savannah Chapter is struggling to sustain itself independently. While the Savannah Chapter has dozens of members, only a handful are consistently engaged, and their chapter is considering a merger with another chapter.Though Atlanta might seem like an obvious partner, our event locations like Charleston, Hilton Head, and Columbia, are actually more convenient for their Savannah area members. In response to this news, our board voted to extend an invitation to Savannah to join us as a subchapter. We have not yet made a formal offer to the Savannah Chapter, but we believe this partnership could be mutually beneficial. We'll keep you updated with any news on this matter.



Thank you once again for the opportunity to serve as your president. I'm proud and excited of what I see and hear about local chapters and hopeful that we can help steer the broader organization toward a brighter future. While there may be challenges ahead at the national level, I believe in the strength, integrity, and resilience of our individual chapters and South Carolina in particular.




